

What will happen if we have concerns for your child?

If school has a concern that your child is, or may be, suffering harm within or outside of school. We will act according to our statutory duty to protect your child from any harm or danger. All schools have a duty to refer cases if they have a safeguarding concern.

What does this mean?

What concerns might we have?

- If someone at our school sees an unusual or unexplained injury or mark;
- If your child has said something that worries us;
- If their behaviour is out of the ordinary; or
- If there is any other reason we feel your child may be suffering harm outside of school, we have a legal duty to make a referral.

We will discuss the concern with you and also let you know if a referral has been made, unless to do so would put your child more at risk by informing you.

It is always better for your child if we can work together.

Introduction

Monkwray Junior School recognises the importance of pupil`s welfare and is proud of comments from its last Ofsted report that said:

‘Leaders have established a strong safeguarding culture across the school. Leaders and staff know pupils and their families well. Staff are quick to act if they are worried about a pupil’s well-being, and leaders act promptly if such concerns arise. They work well with external agencies to secure the support that pupils and families may need. Pupils learn about keeping themselves safe through a well-thought-out curriculum. They said that they feel confident to talk to a trusted adult if they have any worries. .(July 2023)’

As a consequence, Monkwray Junior School will:

- Establish and maintain an ethos where children feel secure and are listened to within an open and positive school atmosphere;
- Ensure that children have an identified adult in school who they can approach if they are worried or in difficulty;
- Plan opportunities and activities into the curriculum for personal, social, health and citizenship development which equip children with the skills they need to stay safe;
- Will make any referrals necessary to ensure the well being of a pupil is safeguarded;
- Ensure that the school is always a safe environment; and
- Ensure that children`s identities and images are protected with regard to published information on the school website, social media and in print.

The role of staff

Staff in school are in a good position to keep a watchful eye on children and their safety and to protect them from harm. If staff have concerns they have a duty to inform the designated Safeguarding Lead—Mrs Willis or, in her absence, Mrs Lamb or Mrs Harker immediately.

All staff have completed the relevant Safeguarding training.

“No single professional can have a full picture of a child`s needs and circumstances and, if children and families receive the right help at the right time, everyone who comes into contact with the, has a role to play in identifying concerns, sharing information and taking appropriate action.”

The role of the Governing body

Safeguarding children is a collective responsibility for the whole of the Governing Body. Every school should have a designated Governor for child Protection, in this school it is Mr Neil Regan.

The role of the parents/carers

If you have a concern about any child, you must raise this with **Cumbria Safeguarding Hub**. They are a team of social workers, police and health workers. You will find general advice at:

Are you concerned about a child?

If you believe them to be at risk of immediate danger call the Police 999 telephone number.

If you believe there is a safeguarding concern which requires a social work response out of hours call the Cumberland Safeguarding Hub on 0333 240 1727 or the Emergency Duty Team on 0300 373 2724 during the weekends or week days after 5pm.

If the duty worker is already responding to a call there is a message facility allowing the caller to invite a call back by leaving their details and a brief summary of their concern.

During busy periods, calls will sometimes have to be prioritised according to needs and council thresholds.

The Safeguarding Hub i/ EDT s a small team of social workers who work shifts; this means that there are only one or two social workers on call to cover the entire county. They are therefore only able to respond to Emergency situations which cannot wait until the next working day.
